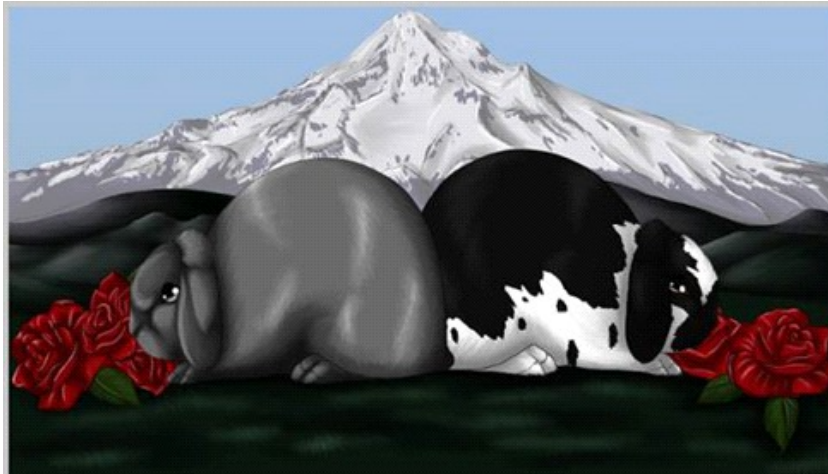

It is the policy of the WSRBA and RRB that rabbits must make the minimum weight for their breed, in order to be in the showroom!!

SHOW RULES

1. This will be an Official ARBA show governed by the Official Show Rules in the 2016-2020 ARBA Yearbook. All rabbits will be judged by the ARBA Standard of Perfection 2016-2020 edition.
2. All rabbits and cavies will be judged as written on the entry forms and all changes must be approved by the show secretary. Ear changes \$ 2.00 each.
3. All rabbits must have a permanent & legible tattoo in the left ear.
- 4 Make all checks payable to The Rebel Rabbit Breeders in US Funds. In addition to any bank charges a \$ 30.00 fee will be charged for any returned checks.
5. Entries must be paid for before the rabbits are judged.
6. All entries must be paid whether the rabbits are judged or not.(No refunds on Scratched animals)
7. RRB reserves the right to add, substitute, or cancel judges as conditions require.
8. Judges decisions will be final. Interfering with the judging will not be tolerated. The final interpretation of the show rules is the responsibility of the show committee. Breeders are encouraged to volunteer as table help during the judging of their breeds.
9. With the exception of the judge, table secretary, table superintendent no one will be allowed behind the tables other than exhibitors placing their entries into the judging coops.
10. Each person is responsible for bringing their rabbits to the judging table when called. No Classes will be rejudged!
11. All entries shall be entered at the sole risk of their owner. The greatest possible care will be given to your entries however, the RRB will not be responsible for any injury suffered by entrants, their guests, spectators, or animals (judges included).
12. No animals other than rabbits/cavies allowed in the showroom
13. Legs and show reports will be mailed or emailed. Ribbons and comment cards must be picked up at the

show.

14. Children must be supervised at all times by an adult, damages by children will be the responsibility of their parents.
15. **This is a carrying cage show. Leak proof cage bottoms are required.**
16. Please fill out your entry form completely and legibly.
17. Underage animals will not be allowed in the showroom!! Rabbits must meet their breed's minimum weights to be in the showroom.
18. RRB reserves the right to refuse entries from all locations within 150 miles which has had a confirmed outbreak of RCD/RHD/VHD within the past 60 days of the entry deadline.
- 19 Submitting an entry indicates acceptance of these rules!
20. No Dogs allowed in showroom, except official service dogs!!
21. ALL Youth animals entered MUST be owned by the youth exhibiting the animal. Violation of this will result in disqualifying of all entries and forfeiting of entry fees.
22. A YOUTH (between the ages of 5-19) must place the youth animals on the show table, unless permission is granted from Show Superintendent.
23. Rebel Rabbit Breeders reserve the right to add, retract or modify any show rule as needed.

Show Rules

- 1. This is an Official ARBA and ACBA sanctioned show and will be governed by the latest Official Show Rules in the 2016-2020 ARBA Yearbook.**
- 2. All cavies will be judged by the ARBA Standard of Perfection 2016-2020 edition.**
- 3. There will be No Smoking in the show area.**

4. Children must be supervised at all time by an adult. Damages by children will be the responsibility of their parents or guardians.
5. All show cavies must have a permanent and legible ID tag in their left ear.
6. No cavies weighing less than 12 ounces are allowed in the show area.
7. There will be no grooming of cavies in the restrooms. No wet cavies or foreign substances on cavies are allowed.
8. Any animals showing signs of disease will be removed from the show room.
9. This is a carrying cage show. All cages must have leak-proof bottoms.
10. Only exhibitors may bring “for sale” cavies in the show area and will only be allowed as space permits.
11. No animals, other than cavies, are allowed in the show area. No Dogs except service dogs are allowed and must remain on leash and controlled by owner at all times.
12. All cavies will be judged per the entry form. All changes must be approved by the Show Secretary.
13. Entry fees must be paid prior to the time judging begins.
14. LCRCC reserves the right to add, substitute or cancel judges as conditions require.
15. Each person is responsible for getting their cavies to the judging table when called and returning them to their set up area after judging is complete. Youth exhibitors must bring their own animals to the table.
16. By submitting an entry, you indicate acceptance of all our show rules and the rules of the ARBA and ACBA that govern this show.

LCRCC reserves the right to request that persons unwilling to comply with posted rules, or persons whose actions or dependents’ actions, present a danger to the welfare of other participants or animals, leave the show. No refund of entry fees will be offered in these situations.

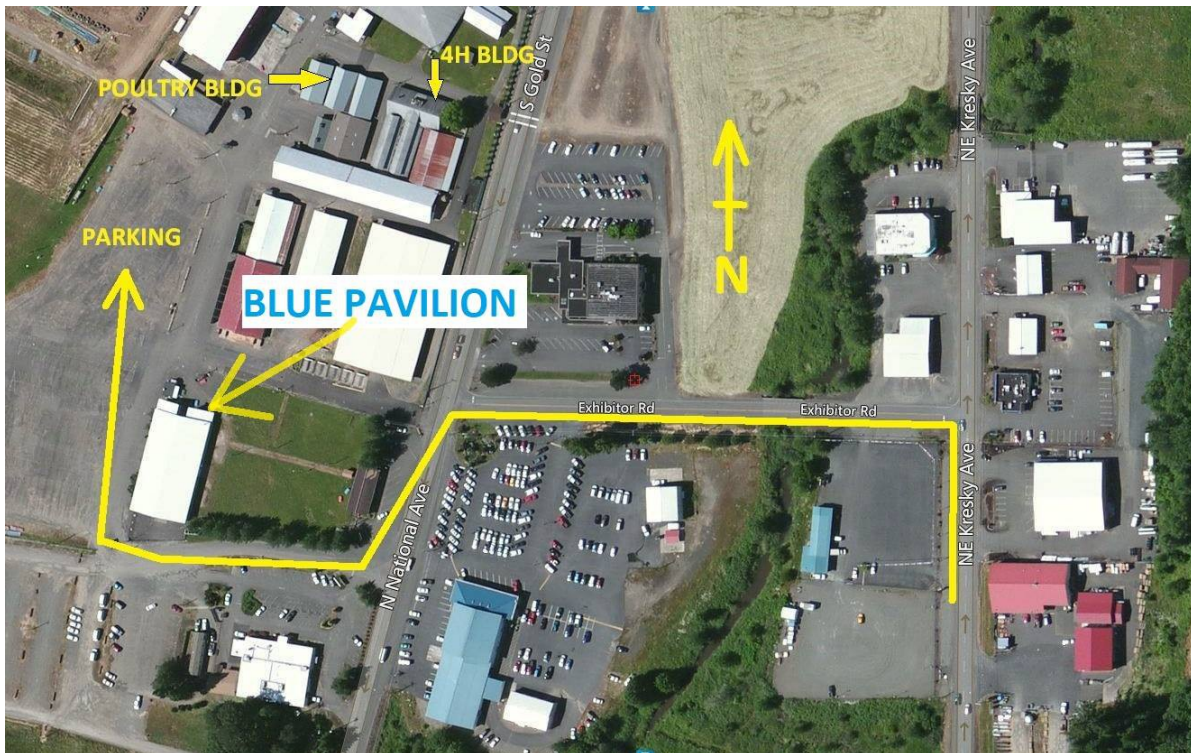
