## SHOW RULES

1. This will be an Official ARBA show governed by the Official Show Rules in the 2016-2020 ARBA Yearbook. All rabbits will be judged by the ARBA Standard of Perfection 2016-2020 edition.
2. All rabbits and cavies will be judged as written on the entry forms and all changes must be approved by the show secretary. Ear changes \$ 2.00 each.
3. All rabbits must have a permanent & legible tattoo in the left ear.
- 4 Make all checks payable to Rabbits Run Wild Youth 4H Club in US Funds. In addition to any bank charges a \$ 30.00 fee will be charged for any returned checks.
5. Entries must be paid for before the animals are judged.
6. All entries must be paid whether the rabbits are judged or not.(No refunds on Scratched animals)
7. RRWYC reserves the right to add, substitute, or cancel judges as conditions require.
8. Judges decisions will be final. Interfering with the judging will not be tolerated. The final interpretation of the show rules is the responsibility of the show committee. Breeders are encouraged to volunteer as table help during the judging of their breeds.
9. With the exception of the judge, table secretary, table superintendent no one will be allowed behind the tables.
10. Each person is responsible for bringing their rabbits to the judging table when called. No Classes will be re-judged!
11. All entries shall be entered at the sole risk of their owner. The greatest possible care will be given to your entries however, the RRWYC, nor Frontier Park will be responsible for any injury suffered by entrants, their guests, spectators, or animals.
12. No animals other than rabbits/cavies allowed in the showroom
13. Legs and show reports will be mailed or emailed. Ribbons and comment cards must be picked up at the show, no awards will be mailed.
14. Children must be supervised at all times by an adult, damages by children will be the responsibility of their parents.
- 15. This is a carrying cage show. Leak proof cage bottoms are required.**
16. Please fill out your entry form completely and legibly.
17. Underage animals will not be allowed in the showroom!! Rabbits must meet their breed's minimum weights to be in the showroom.
18. RRWYC reserves the right to refuse entries from all locations within 150 miles which has had a confirmed outbreak of RCD/RHD/VHD within the past 60 days of the entry deadline.
- 19 Submitting an entry indicates acceptance of these rules!
20. No Dogs allowed in showroom, except official service dogs!!
21. ALL animals entered MUST be owned by the youth exhibiting the animal. Violation of this will result in disqualifying of all entries and forfeiting of entry fees.
22. Adults will not be allowed to put youth's animals on the tables without permission from show personnel.
23. Youth Exhibitors must have turned 5 years old on or before the date of the show and must not have had their 19<sup>th</sup> birthday before the date of the show.
