- Breed Specialty award point report showing which awards receive a ARBA leg. (in Gesswein Grand Champion Show Program this is listed under Quick Reports - Breed Specialty Points).
- If meat classes (meat pen, single fryers, roasters & stewers) are shown, please send a judging control sheet with placings listed and I will calculate points OR send the After Show Reports - Specialty Club Placement Report for each meat class.
- If fur classes are shown, please send a judging control sheet with placings listed and I will calculate points OR send the After Show Reports - Specialty Club Placement Report for each fur class.

If you use another computer program, have any trouble with what to send, or are not sure how to format please contact me and I will be happy to help you. **Incomplete reports or reports not in alphabetical order will be returned.**
